## Official Contest Rules « 2025 Summer Giveaway – Parts City Auto Parts ».

## 1. **ELIGIBILITY**

The "2025 Summer Giveaway – Parts City Auto Parts" is open to eligible residents of Quebec and the Atlantic provinces.

Employees, officers, and directors of Vast-Auto Distribution Ltd. (Parts City Auto Parts) (the "Sponsor"), as well as its affiliates, including its parent companies, subsidiaries, related companies, representatives, agents, the agency responsible for organizing the contest, advertising and promotional agencies, and each of their immediate family members (defined as parents, spouses, siblings, and children, regardless of place of residence) and those with whom they reside (whether or not they are immediate family members) are not eligible.

## 2. CONTEST PERIOD

The contest begins on June 15, 2025, at 7:00 a.m. (ET) and ends on August 15, 2025, at 11:59 p.m. (ET) (the "contest period"). The Sponsor's computer server is the sole determinant of the date and time of entry receipt and is the official timekeeping device for this contest.

#### 3. ENTRY

No purchase necessary. Participants from Quebec and the Atlantic provinces are invited to scan the QR code available in-store and subscribe to the newsletter on the contest webpage (https://partscityautopromo.ca/) to be automatically entered into the contest.

A contest entry requires the participant to provide their first and last name, a valid phone number, a valid email address, and to select the Parts City Auto Parts store from which they are entering. Standard internet and usage fees may apply, as charged by your internet or mobile service provider.

To enter the contest, participants must:

- a) Scan the QR code at a participating Parts City Auto Parts store. This will lead to the "2025 Summer Contest Parts City Auto Parts" webpage (https://partscityautopromo.ca/). Complete the newsletter subscription form by providing your first and last name, a valid phone number, a valid email address, and selecting the Parts City Auto Parts store from which you are entering.
- b) Agree to the contest rules, available online, and accept to comply with them.
- c) Be 18 years of age or older.

Participants may enter only once per store. Each participant can win only one prize per store, which is one (1) of the 18 summer product bundles, each valued at \$400. This prize is non-transferable. Anyone who submits more entries than the allowed limit of one entry per store will be disqualified, and all entries submitted by that person during the contest period will be voided.

Late, lost, stolen, ineligible entries, or entries containing incorrect or incomplete information, submitted in a non-compliant manner, or not respecting the terms of these rules will be disqualified. All entries become the property of the Sponsor upon receipt and will not be returned. The Sponsor is not responsible for lost, late, illegible, incomplete, or misdirected entries. The Sponsor is not responsible for any warranties on the products included in the prize bundles.

## 4. PRIZES

There is only one (1) prize to be won per store, for a total of eighteen (18) summer product bundles, each valued at \$400. The chances of winning one of these prizes depend on the number of entries received during the contest period.

Prizes must be accepted as awarded and cannot be transferred, sold, gifted, assigned, or exchanged. Prizes may differ from those illustrated in the

contest advertising or promotional materials. The Sponsor reserves the right to substitute any prize with one of equal or greater value if the original prize is unavailable for any reason. All expenses, taxes, and costs related to the acceptance and use of a prize that are not mentioned in these rules are the responsibility of the winners.

### 5. WINNER SELECTION

Prizes will be awarded by a random draw conducted among all eligible entries received per store.

The draw will take place on August 18, 2025, at 9:00 a.m. (ET).

Each winner will be contacted by email and/or phone within ten business days following the draw date. To be declared a winner, the winner must:

- a) Be entered in the contest by subscribing to the Parts City Auto Parts newsletter through the form on the contest webpage (https://partscityautopromo.ca/).
- b) Sign and return a declaration, waiver, release, and advertising consent form confirming, among other things, that they have complied with the contest rules and releasing the Sponsor, its employees, representatives, agents, advertising and promotional agencies, affiliates, directors, officers, shareholders, partners, subcontractors, distributors, successors, and assigns (collectively, the "representatives") from any liability related to the prizes won (the "declaration") within 5 days of being notified that they have won the prize.

They will be contacted to arrange the pickup details.

c) Consent to the collection of their personal information by the Sponsor for the purposes mentioned above.

## 7. LIMITATION OF LIABILITY
